5. Executive Director's Report

Maria Ayerdi welcomed Tony Hall to the TJPA. He has been a strong supporter of the Transbay Terminal and the downtown extension.

Negotiations with Caltrans over the land transfer for the project are continuing. We are trying to follow AB 1419. The transferees will be the same. We are working on a schedule for the Transbay Project and the retrofit of the West Approach.

MTC adoption of the RTP will take place on March 15.

The Redevelopment Agency has the Plan Adoption Consultants in place to do the work necessary to adopt the redevelopment plan at the end of this year or early next year. Work entails a fiscal feasibility analysis, the report on blighting conditions and applicability of redevelopment.

8. Informational presentation on the environmental document for the Transbay Terminal/Caltrain Downtown Extension Project.

Joan Kugler, San Francisco Planning Department project coordinator, reviewed the status of the Environmental Impact Report and Statement for the Transbay Terminal and Caltrain Extension Project. The EIS/EIR is set to be released for public comment shortly and will be presented to the TJPA at the next meeting. The EIS/EIR identifies and analyzes various needs and alternatives.

Director Harper asked for clarification about the BART connection. Ms. Kugler stated that the connection isn't part of the basic project but is included as an option. Director Ayerdi stated that there is no funding currently identified for the BART connection but it has local support.

Director Harper asked about accommodations at the terminal for people being dropped off. He suggested that staff take a position on the matter.
