#### 1. Call to Order

Chair Larkin called the meeting to order at 5:33 p.m.

#### 2. Staff Report (15 minutes)

Lily Madjus Wu, TJPA Communications and Legislative Affairs Director, presented the Staff Report.

Chair Larkin requested that information on the Caltrain event mentioned on September 23 be sent out to members.

#### **Public Comment:**

Roland LeBrun suggested that members watch the September 13, 2023, Metropolitan Transportation Commission (MTC) meeting, specifically the Programming Allocations Committee's progress report on Major Program Advancement Policy, and also the Caltrain board meeting on September 7, 2023 for a presentation by Caltrain on TJPA's Downtown Rail Extension and other related projects.

## 3. Approval of Meeting Minutes: August 8, 2023

There was no member of the public wishing to comment. A motion to approve the minutes was made by Member Schatmeier and seconded by Member Munoz. Member Burnett, Vice Chair Shaw, and Chair Larkin abstained. A majority vote approved the motion.

4. Downtown Rail Extension Workplan Schedule Update (10 minutes)

Anna Harvey, TJPA Deputy Project Director, presented the item.

Member Mendez requested access to the public documents that would allow him to best understand the Governance plan and applicable Memorandum of Understanding (MOU) for the San Francisco Peninsula Rail Program. Staff confirmed the items (MOU June 2020, Accelerated Workplan April 2021, and Governance Blueprint August 2023) presented to the TJPA Board were on the TJPA's

website and links would be forwarded to the CAC Members to provide context on the Governance plan.

### **Public Comment:**

Roland LeBrun stated that The Portal project has room for improvement such as additional coordination with other public projects in the vicinity of The Portal and also extensive value engineering to make the project more competitive for funding.

- R.E. Walsh, TJPA Facility Director, presented the item.
- 6. Public Comment

Roland LeBrun informed members that there would be an informative California High Speed Rail Authority meeting on September 13, 2023, regarding the Brightline West high speed rail project that will run 200 miles from Los Angeles to Las Vegas, that is planned to be built in four years for \$12 billion, and of the plans to activate the space surrounding the stations.

Member Chan asked for an update on the former Temporary Transbay Terminal parcels and its future uses.

Future agenda requests include: 1) presentation on train doors and platform heights; 2) AC Transit update on the Bay Bridge Forward project (Bus Only Lane on the Bay Bridge); 3) San Francisco County Transportation Authority update on Southeast Railyard Station Study; 4) presentation on the Operating and Maintenance plan for the station once it is built beneath the Transit Center; 5) Small Business and Disadvantaged Business Enterprise commitment for DTX; and 6) Office of Community Investment and Infrastructure (OCII) update on the former Temporary Transbay Terminal parcels and its future uses.
