





- Installing retail leasing signs





Facility Readiness - Transit


- SFMTA Right of Entry for early start of 5-Fulton in Bus Plaza complete

- Amtrak 2nd floor lease stalled



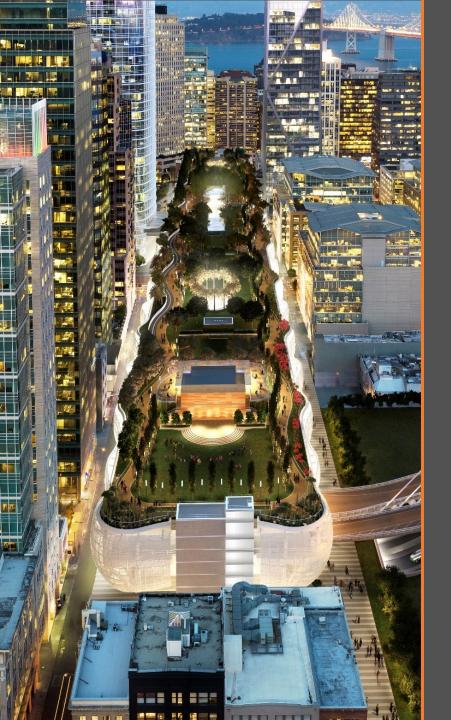


Facility Readiness - Security
