  - Temporary Terminal Schematic Design
  - Caltrain Downtown Extension (DTX) Update
  - Funding Update

Executive Director (ED) Ayerdi reported on the items to be presented.

Phil Sandri, URS/Transbay Program Management Team-Project Manager for Temporary Terminal, presented the Temporary Terminal Schematic Design.

Bradford Townsend, URS/Transbay Program Management Team-Project Manager for DTX, presented the DTX update including the DTX loop cost analysis. ED Ayerdi announced that money has been identified for DTX Preliminary Engineering (PE) Phase 2 so that work could continue in January 2008 since PE Phase 1 money runs out at the end of this year.

Nancy Whelan, Transbay Financial/Nancy Whelan Consulting, and John Harmer, URS/Transbay Program Management Team, presented the Funding Update which included an updated (preliminary cost estimate) Baseline Budget for Phase 1, which is fully funded.



ED Ayerdi also announced that an OCIP (owner controlled insurance program) and CM At-Risk (method of contract delivery) would be presented at a future meeting as a strategy to ensure the TJPA. She further stated that the contract with Pelli/Hines in under negotiations and should be presented by April 2008.

6. Public Comment

Jane Morrison, SF Tomorrow, stated they are 1000% in support of the Transbay Project but expressed concern over City Planning approving so many high rises. They support the project's needs to have a high rise to fund the project but hope it is not as high as 1300 feet.
