2. Staff Report (10 minutes)

Lily Madjus Wu, TJPA Communications and Legislative Affairs Director, presented the Staff Report. She concluded by recognizing outgoing members Richard Burnett, Mark O'Dell and Andrew Robinson for their service on the CAC.

3. Approval of Meeting Minutes: January 9, 2024

There was no member of the public wishing to comment. A motion to approve the minutes was made by Member Schatmeier and seconded by Member Munoz. Chair Larkin abstained. A majority voice vote approved the motion.

4. Program Update by the California High-Speed Rail Authority (CHSRA) (20 minutes)

Morgan Galli, CHSRA Northern California Deputy Regional Director, presented this item.

Member Mendez asked about how Geographic Information System (GIS) information correlated to demographics for the CHSRA project and he also asked how the CAC members could attend a tour of the project. Ms. Galli stated she would coordinate with TJPA staff on a potential tour. Nila Gonzalez, TJPA Chief of Staff, suggested that Ms. Galli connect Member Mendez with the CHSRA GIS team.

# **Public Comment:**

Roland Lebrun shared updates on HSRA efforts, including HSRA presentations at both the California Assembly and Senate Transportation Committees this week; the importance of rail transport manufacturer Alstom's recent purchase of a factory in the Bay Area; and he suggested that CHSRA change their proposed project alignment to go directly south from Gilroy to Fresno instead of turning east towards Merced as a cost savings.
