1. Call to Order

Vice Chair Shaw called the meeting to order at 5:30 p.m.

2. Staff Report (10 minutes)

Lily Madjus Wu, TJPA Communications and Legislative Affairs Director, presented the Staff Report.

Public Comment:

Roland Lebrun reported that google maps shows 400 miles between TJPA Salesforce Transit Center and Los Angeles Union Station and noted that California High Speed Rail Authority's (CHSRA) project is well over that amount of distance.

3. Approval of Meeting Minutes: June 11, 2024

There was no member of the public wishing to comment. Member Thompson motioned to approve the minutes; it was seconded by Member Nachor. A majority voice vote approved the motion. Member Paterson abstained.

5. The Portal Update including the plan to develop an updated Master Schedule reflecting a new Full Funding Grant Agreement (FFGA) target of July 2027, and advance risk mitigation strategies, including limited procurement activities, consistent with the approved Governance Blueprint. (20 minutes)

Stephen Polechronis, AECOM Program Contract Manager for the Program Management and Construction Management (PMCM) consultant, and Adam Van de Water, TJPA Executive Director jointly presented the item.

Public Comment:

Jim Patrick, Patrick and Company, suggested ideas for financing the project by getting a credit loan and a tunnel tax to provide a revenue stream.

Roland Lebrun reported on finance methods used by East Coast transit projects and possible financial loans that The Portal could use.

6. Public Comment

Roland Lebrun suggested federal funding sources that The Portal could pursue, and he stated that if CHSRA changed their route to match the highway corridor they could save \$24 billion.
